the benefits and opportunities afforded my child by his/her participation in the field trip, I state as
follows:

I authorize the school representative to obtain medical treatment for my child in the event of injury or
illness and agree to pay any expense incurred for treatment.

I understand that under present Florida law, if my child is riding in a private passenger automobile which
is involved in an accident, he/she may be primarily covered for bodily injury under my family automobile
policy and I agree to submit any medical bills incurred to my insurance company for payment. If my
policy has been issued with a deductible clause relative to the personal injury protection, I understand
that I have assumed that deductible amount when I purchased the policy. The School Board will not be
responsible for my deductible on primary coverage.

If my child is being transported in commercial carrier or other leased or rented vehicles and an injury
occurs, I shall look to the commercial carrier or owner of the other leased or rented vehicle to pay any
medical bills incurred as a result of such injury and shall release the School Board from liability.

If my child is otherwise injured during the trip, I agree and understand that liability arising out of the
above trip is assumed hereby and shall be the sole and exclusive risk of the undersigned.

NOTE: The undersigned and the student agree to assume all risk of injury that may occur during the
above described trip.

Furthermore, I understand that my son/daughter is responsible for following all rules outlined in the

GRAD NITE DRESS CODE

WHAT'S IN

Girls— Dresses, skirts, shorts, casual pants (including jeans), blouses and tops, and comfortable shoes (including tennis shoes, dress sandals, and boots).

Guys— Casual pants (including khaki style, shorts and jeans), shirts with collar (golf style shirts, dress shirts), sport jackets, dress suits, comfortable shoes (including tennis shoes, sandals, dress shoes, and boots).

WHAT'S OUT

- Any clothing affiliated with a school, professional sports team, group, club, etc.
- Clothing not in good repair (torn jeans, pants, shirts, etc.) Jeans are okay as long as they are not ripped or torn.
- Revealing clothing (i.e. bathing suit tops or bottoms, cropped tops, see-through clothing, etc)
- Hats and/or Bandanas (Either worn or hanging from belt loops/pockets, etc.)
- All backpacks. Small purses and hip bags are okay.

- Weapons, knives, laser pointers or chemical irritants are not permitted. Students or chaperones not following this guideline will be dealt with at the discretion of the Orange County Sheriff's Office.
- Alcohol and tobacco products are not allowed and will be confiscated and not returned if found onsite.

Please note: Failure to follow the guidelines may result in delayed admission and/or denial of admission to your Disney Grad Nite event. Also, Walt Disney World Cast Members have the right to refuse admission to anyone they deem not appropriately dressed for the event and not following these guidelines. The dress code for Disney Grad Nite will be enforced throughout the event by all Cast Members working the event. Note: Some schools may enforce a stricter dress code.

The dress code list is for descriptive purposes and is not all-inclusive; other attire which does not conform to the standards set forth above will be deemed inappropriate. Students not properly dressed, as set forth above, will be refused admittance and will be denied a refund of any kind. If you are unsure whether or not something is acceptable, don't wear it!
